

MEMORANDUM OF UNDERSTANDING ON FRIENDLY EXCHANGE

BETWEEN
THE YAMANASHI PREFECTURAL ASSEMBLY OF JAPAN
AND
THE UTTAR PRADESH LEGISLATIVE ASSEMBLY OF THE REPUBLIC OF INDIA

The Yamanashi Prefectural Assembly of Japan and the Uttar Pradesh Legislative Assembly of the Republic of India (hereinafter referred to collectively as the "Two Assemblies"), with a view to building a mutually beneficial relationship between Yamanashi Prefecture and Uttar Pradesh, shall respect the spirit of the Basic Agreement concluded between the two governments on **23 December 2024**, support its implementation, and promote the development of close and friendly relations between the Two Assemblies.

ARTICLE 1: FRIENDLY EXCHANGES & MUTUAL TRUST

The Two Assemblies shall endeavour to promote friendly exchanges through mutual visits, exchange of information, and other exchange activities between the assemblies in order to deepen mutual understanding and strengthen relations of trust.

ARTICLE 2: AREAS OF COOPERATION & DEVELOPMENT

The Two Assemblies shall also support the promotion of exchanges and cooperation in the fields of economy, tourism, agriculture, education, human resource development, and other areas of mutual interest pursued by Yamanashi Prefecture and Uttar Pradesh, and shall endeavour to provide the necessary cooperation for the development of exchange programs and cooperative projects.

ARTICLE 3: PRINCIPLE OF MUTUAL PROSPERITY

Based on the foregoing principles, the Two Assemblies hereby conclude this Memorandum of Understanding with the aim of contributing to mutual development and prosperity.

ARTICLE 4: LEGAL NATURE

This Memorandum of Understanding confirms the intention of the Two Assemblies regarding friendly exchanges and cooperation and does not create any legally binding obligations.

ARTICLE 5: LANGUAGES & AUTHENTICITY

This Memorandum of Understanding shall be executed in duplicate in both the Japanese and English languages, with each Assembly retaining one original in Japanese and one original in English.

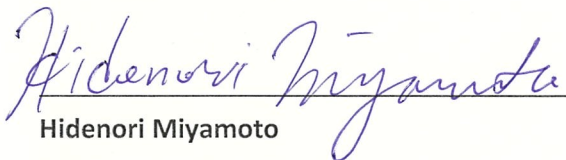
ARTICLE 6: EFFECTIVE DATE & DURATION

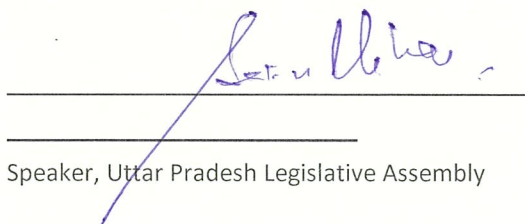
